As a parent/guardian, I understand and agree to comply with the following camp rules that are instituted by the Municipality of Norristown, Department of Recreation. I understand that it is my responsibility to make my child aware of expectations and co-operative behavior that is necessary to participate in the Municipality of Norristown Summer Playground Program. As the responsible adult, I also understand my role in abiding by the rules and agree to comply.

SUMMER CAMP RULES AND REGULATIONS
All Children who are attending a field trip MUST WEAR their camp t-shirt that day
Camp Leaders are the principle authority during program times and will make all final decisions
Profanity will not be tolerated.
Verbal and non/verbal fighting will not be tolerated.
Smoking, alcohol and drugs are not permitted.
Bikes may not be ridden during camp hours.
No glass containers or sharp objects may be brought to the camp site or on any off-site trips.
DISMISSAL/CAMPER PICK-UP
Campers may not leave the camp site before the designated dismissal time without the written permission of the parent/guardian.
Dismissal time is 2:45 pm. Any child left at the camp after 2:45 without transportation home will receive a written warning. Repeated occurrences will result in a monetary fine for every incident after the first time a child is without transportation since staff is required to remain on site until the child is picked up.
PERSONAL PROPERTY
If your child comes with personal equipment, (i.e. I-pod, I-pads, cell phone, electronic gaming devices, etc.) make sure to clearly label each piece with your child's name. Please note that the child will be solely responsible for any personal equipment brought to the program site or on of-site trips.
APPROPRIATE DRESS
Due to the summer weather, please be sure to have your child dress appropriately in light clothing and shoes (no sandals).
